
Fund Description and Objective

GEC – Global Enhanced Cash is an open-end UCITS V compliant fund. The fund aims to capital preservation with the objective of generating excess return with respect to the European Central Bank short term rates. The fund will invest in cash, cash equivalents and fixed income instruments, including but not limited to deposits, fixed and floating interest rate debt securities, issued by government and corporate issuers, with an average duration below 12 months.

Market Commentary

Last month the Fixed Income world finally made a come back. Supported both by weak inflation data and high volatility, euro rates gapped in and tightened around 35 bps across the curves with medium-term maturities benefiting the most. Credit spreads' performance was also positive, delivering a compression of 50/60 bps roughly, which now means that IG/HY yields have tightened around 100/150 bps since the beginning of the year.

Performance Commentary


In January Global Enhanced Cash delivered a net performance of +0.58%. At portfolio level, as you would expect, the main contributor was credit, with short-rate hedge costs of around 5 bps.


For February, the dilemma is that, should we look at market performances, we can affirm that fixed income and equity are telling us two different stories. From a macro perspective, inverted curves usually mean recession. We do not believe this to be the case as short-term yields shot up due to inflationary pressures, pushing historical rates above the highest point on the belly of the curve (technical inversion). On the other hand, it is probably too early to state inflation is over. For that reason, we prefer to keep a neutral duration exposure and to keep a pro-active stance should we see spikes again (increasing 0.2/0.3y in duration).




Monthly Gross Performance breakdown (in basis points)






Sector Breakdown (Only Long positions)








