
Fund Description and Objective

Income Opportunity is an Absolute Return multi-strategy fund. The investment objective is to deliver steady capital appreciation with contained volatility, regardless of the directional movement in equity, interest rates, credit or currency markets.

Market Commentary

Last month we increased our fixed income exposure preferring high-quality bonds (rate related) and financial subordinated assets (up to 2.4y). The Fixed Income world finally made a come back. Supported both by weak inflation data and high volatility, euro rates gapped in and tightened around 35 bps across the curves with medium-term maturities benefiting the most. Credit spreads' performance was also positive, delivering a compression of 50/60 bps roughly, which now means that IG/HY yields have tightened around 100/150 bps since the beginning of the year. Equity wise, January was an unexpectedly strong month. European exchanges were up around 10% on average, while US stock markets recorded the best monthly performance in a while in a range of 6-10%.

Performance Commentary

In January Income Opportunity delivered a net performance of +0.62%

At portfolio level, we kept a prudential approach. The major contributor was the high yield sector at +80 bps, followed by Investment grade bond (+34bps). Equity long-short strategy was flat for the month.


FOr February, the dilemma is that, should we look at market performances, we can affirm that fixed income and equity are telling us two different stories. From a macro perspective, inverted curves usually mean recession. We do not believe this to be the case as short-term yields shot up due to inflationary pressures, pushing historical rates above the highest point on the belly of the curve (technical inversion). On the other hand, it is probably too early to state inflation is over. For that reason, we prefer to keep a neutral duration exposure and to keep a pro-active stance should we see spikes again (increasing 0.2/0.3y).





Strategies Breakdown




Country Breakdown


